PRA Project approach



Assessment and compilation of best practices for PC-IDEA members

1. Survey of Best Practices (January – July 2011)
2. Analysis of findings and needs (August – September 2011)
3. Dissemination of good practices for PC-IDEA (October 2011)
4. Development of guidelines for the implementation of SDIs in the Americas (November 2011 – July 2012)

FINAL PRODUCTS:

- Report on the results of the survey
- Guidelines for the implementation of an SDI in the Americas



Preparation for the Survey

- Studied the structure and content of previous PC-IDEA surveys and other global surveys related to SDI.
- Defined: What is a **best practice**?
 - **Documented resources**
(Guides, guidelines, instructions, manuals)
 - **Anecdotal evidence**
(Case studies, success stories)
- Reviewed other work that has already been done on best practices in the implementation of SDIs:
 - World Bank study on the development of a “how-to” guide on SDI for resource-scarce countries
 - SDI Information Policy Best Practices
(Both presented at the GSDI 12 Conference in Singapore.)



PRA Questionnaire



Address the key components of the SDI:

1. **Policies** (Regulatory framework, privacy, licensing, etc.)
2. **Standards** (Implementation, metadata, Web Map Service, etc.)
3. **Technology** (Open source, cloud computing, data dissemination, etc.)
4. **Framework Data** (Dissemination practices, base layer development, etc.)
5. **Other** (Capacity building, governance, leadership, funding etc.)

Focus on:

- existing guidelines and documents within member country
- case studies and success stories for SDI implementation
- existing guidelines and best practices outside of PC-IDEA region
- needs for best practices and guidelines within member country
- needs by target audience (technical, managerial/policy, users)

3. Develop glossary/lexicon (*glosario/léxico*) of terms that are adopted by the Working Group to support the PC-IDEA initiative (Canada/Chile/Brazil)
4. Develop guidelines for the implementation of SDIs in the Americas based on the results of this workplan for PRA
