

## Twelfth Session of the United Nations Committee of Experts on Global Geospatial Information Management (UN-GGIM) UN-GGIM: Americas Side Event

### CONCEPT NOTE

#### Background

The United Nations Committee of Experts on Global Geospatial Information Management (UN-GGIM) established by the United Nations Economic and Social Council (ECOSOC), is a formal intergovernmental mechanism to discuss, improve and coordinate the availability and use of geospatial information at the global level, through the participation of the Member States of the United Nations.

In August 2013, the Regional Committee for the Americas (UN-GGIM: Americas) was created, replacing the Standing Committee on Geospatial Data Infrastructure of the Americas (PC-IDEA). This significant action was carried out in accordance with the new mandate of the Regional Committee to enhance cooperation and coordination with the United Nations Committee of Experts on Global Geospatial Information Management (UN-GGIM). The Regional Committee, aligned with the global architecture, would better address regional and global challenges, especially in the context of sustainable development.

The Regional Committee for the Americas (UN-GGIM: Americas) determines the relevant regional issues for the management of geospatial information, and takes the necessary measures to maximize the economic, social and environmental benefits derived from its use. The foregoing based on knowledge and the exchange of experiences and technologies by Member States, which allows promoting the establishment of Geospatial Data Infrastructures in the Americas and other national initiatives, in addition to contributions to debates in UN- GGIM.

This meeting seeks the interaction of the Member States of the Regional Committee for: Exchange on challenges and expectations of the UN-GGIM: Americas working groups, networks and initiatives; provide an overview on the cross collaboration that can be put in practice to best execute the proposed activities for the workplans; get an agreement on the expected progresses of the UN-GGIM Americas workplan by November 2022, so as to present them in the Ninth Session of the Regional Committee.
